## Memorandum of Understanding

An ISO 9001 2003 Company

1. SOFCON INDIA PVT. LTD. (Sofcon) will conduct Remote Training Program for 2<sup>nd</sup> year students from 14<sup>th</sup> May 2020 for 4 weeks.

2. Due to the "Lockdown" condition, the training would be imparted Remotely. The sylabii to be covered has already been mutually agreed upon, between Bharati Vidyapeeth and SOFCON.

3. Any dispute arising during the course of the execution of the contract shall be settled through with mutual discussions.

4. SOFCON shall depute a team of at least 2 trainers for the On Line training and would adhere to the Time Table of the program, to be published before the commencement of the Training Program.

5. SOFCON shall provide the desired study material to each student.

6. SOFCON shall complete the evaluation of the students trained (in theory and practical/project both) and submit a mark list, where 100 is the Maximum Mark.

 SOFCON shall keep attendance record of each student and submit to the Program Coordinator, appointed by Bharati Vidyapeeth. At the end of the program, the final attendance data should be submitted along with the Mark List.

8. SOFCON & Bharati Vidyapeeth shall jointly offer Certificates to the successful students. However, SOFCON shall print & prepare the certificates.

9. Mode of Payment

1st installment of 50% of the total amount will be made within 2 weeks of commencement of the training program.

<sup>2nd</sup> installment of remaining 50% will be made within 2 weeks of completion of training.

 SOFCON will submit Invoice/Bills before the payment and the payment will be processed after the submission of their Invoice/Bills.

11. All payments will be through digital payment mode in the favour of Sofcon India Pvt. Ltd. SOFCON would provide the necessary Bank details to Bharati Vidyapeeth, New Delhi.

 Final price as agreed mutually is Rs. 2,47,500/- (Rupees Two Lakh Forty Seven Thousand Five Hundred Only) for 55 students for 4 weeks In House Technical Training, inclusive of GST @ 18%.

13. Every Extra Student, if they join, shall be charged @ Rs. 4,500/- (Tax inclusive) by SOFCON.

14. Before making the payment, statutory TDS will be implemented. Necessary document regarding the TDS will furnished by the College later.
