3. Any dispute arising during the course of the execution of the contract shall be settled through mutual discussions.
4. **Vision Automation Solutions** shall depute a team of at least 2 trainers on 30-40 students (1 for theory classes 1 for Labs in batches).
5. **Vision Automation Solutions** shall provide the desired study material to each student.
6. College shall provide the Lab assistance for training period.

6. College shall provide the Lab assistance for training period.
7. **Vision Automation Solutions** shall complete the evaluation of the students trained (in theory and practical both) and submit a mark list, where 100 is the Maximum Mark.
8. **Vision Automation Solutions** shall keep attendance record of each student and submit the final attendance data.
9. **Vision Automation Solutions** & Bharati Vidyapeeth shall jointly offer Certificates to the successful students. However, **Vision Automation Solutions** shall print & prepare the certificates.
10. A Short-Term Course on Power System Restructuring and Renewable Energy Integration (PSRREI 4.0) will be organized by the company for faculty after the training program.
11. The **Vision Automation Solutions** will help in recruitment of 5-7% Best Interested Students in Core Sector.
12. The Company will arrange for an Industrial Visit for the students.
13. Mode of Payment

 - 2nd installment of remaining 50% will be made within 2 weeks of completion of training. ~~against tax invoice.~~
14. All payments will be through cheque drawn in the favor of **Vision Automation Solutions**. However, if **Vision Automation Solutions** prefers to have the payments in electronic mode, necessary Bank details to be provided.
15. Final price as agreed mutually is Rs. 4000/- (Four Thousand Rupees Only in words) for min 30-40 students for 5 weeks In House Technical Training, inclusive of GST @ 18%.
16. Final Price as agreed mutually is Rs. 1,64,000/- (Rupees One Lac Sixty-Four Thousand only in words) for 41 students for 5 weeks In House Technical Training, inclusive of Taxes.
17. Every Extra Student, if they join, shall be charged @ Rs. 4,000/- (Tax inclusive) by **Vision Automation Solutions**.
18. Before making the payment, statutory TDS will be implemented. Necessary document regarding the TDS will furnished by the College later.
