

Memorandum of Understanding

This Memorandum of Understanding (MoU) is executed on 24th July 2023 via offline between

Whereas, sharing a common desire to explore, extend and strengthen their functional relationship, BVCOE, Delhi and Brain Mentors Pvt Ltd. do hereby agreed to explore the feasibility of collaborating in Niche Technologies, skill enhancement and talent management. Accordingly, the broad features of this Memorandum of Understanding are as follows: -

1. Brain Mentors Pvt Ltd will conduct In House Training Program for 2nd year students from 24th July 2023
2. Hardware, Infrastructure & Operational requirements available in the College have been examined by Brain Mentors Pvt Ltd and shall be provided to them.
3. Any dispute arising during the course of the execution of the contract shall be settled through with mutual discussions.
4. Brain Mentors Pvt Ltd shall depute a team of at least 2 trainers on 30-40 students (1 for theory classes 1 for Labs in batches)
5. Brain Mentors Pvt Ltd shall provide the desired study material to each student.
6. College shall provide the Lab assistance for training period.
7. Brain Mentors Pvt Ltd shall complete the evaluation of the students trained (in theory and practical both) and submit a mark list, where 100 is the Maximum Mark.
8. Brain Mentors Pvt Ltd shall keep attendance record of each student and submit the final attendance data.
9. Brain Mentors Pvt Ltd & Bharati Vidyapeeth shall jointly offer Certificates to the successful students. However Brain Mentors Pvt Ltd shall print & prepare the certificates.

10. Mode of Payment

1st installment of 50% of the total amount will be made within 2 weeks of commencement of the training program against invoice.

2nd installment of remaining 50% will be made within 2 weeks of completion of training against invoice.

11. All payments will be through cheque drawn in the favor of Amit Srivastava. However, if Brain Mentors Pvt Ltd prefers to have the payments in electronic mode, necessary Bank details to be provided.

12. Final price as agreed mutually is Rs. 4300/- (Four Thousand Three Hundred Rupees Only in words) for 66 students in MERN STACK In House Technical Training, inclusive of TDS @ 10% . The amount shall transfer in Saving A/C only.

13. Before making the payment, statutory TDS will be implemented. Necessary document regarding the TDS will furnished by the College later.
